WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993. - NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants permission to Vishun Rajdeo Teachers Training College, Plot No. 685, 1, 2, Street No. 12, Vill-Kiratpur Rajaram, Po-Bhagawanpur, Tehsil/Taluka-Lalganj, Town/City-Hajipur, Dist.-Vaishali, Bihar-844114 for conducting D.El.Ed. programme of two years duration with an intake of 100 (two basic units) from the academic session 2018-2019 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 4. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report of the end of each academic year along with the statement of annual account and audited by a Chartered Accountant.

 - d) Names of Students admitted during the current session along with qualification. Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter:
 - n) Number of books in the library, journals subscribed to, and additions any, in the last quarter:
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, if it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
